

NOTICE TO BIDDERS

Sealed Bids for furnishing labor and materials for:

BOGERT ROAD SECTION 10, BOROUGH OF RIVER EDGE, BERGEN COUNTY, NEW JERSEY will be received and opened by the Borough Administrator of the Borough of River Edge, County of Bergen, State of New Jersey, in the Council Chambers of the Borough Hall, 705 Kinderkamack Road, River Edge, New Jersey, on **October 6, 2026, at 10.30AM.**

BASE BID

The scope of work includes approximately:

3,850 Square Yards of HMA Milling, 2" Thick (3" Pay Limit); 530 Tons of Hot Mix Asphalt M 64 Surface Course, 2" Thick; 69 Tons of Hot Mix Asphalt 19 M 64 Base Course, 8" Thick; 1,407 L.F. of 9" X 18" Concrete Vertical Curb; 11 S.Y. of Detectable Warning Surface; 569 S.Y. of Concrete Sidewalk, 5" Thick; 53 S.Y. of Concrete Sidewalk Reinforced, 6" Thick; 188 S.Y. of Concrete Driveway, Reinforced, 6" Thick; 45 S.Y. of Hot Mix Asphalt Driveway, 2" Thick; 19 L.F. of Belgian Block; 2 S.Y. of Brick Pavers; 80 C.Y. of Borrow Topsoil; 550 S.Y. of Topsoil Spreading, 5" Thick; 550 S.Y. of Fertilizing and Seeding, Type A-3; 550 S.Y. of Straw Mulching.

The Time of Completion for this project shall be forty-five (45) calendar days from the date established in the Notice to Proceed.

Liquidated Damages shall be assessed at the rate of \$500.00 per calendar day for each calendar day beyond the specified Time of Completion.

The Maintenance Guarantee for this project shall be 100% of the final project cost and shall remain in effect for a period of two (2) years from the date of acceptance of the completed work by the Borough.

The Borough's preference is for construction to commence in early Spring 2027. However, should weather conditions and seasonal limitations permit the Contractor to complete the work prior to that time, an earlier construction schedule may be considered, subject to coordination with and approval by the Borough.

Copies of the specifications and drawings will be furnished to each bidder for **\$150 for hard copies** or **\$50 for electronic copies** (which is non-refundable), **Payable to Costa Engineering Corp.**, The Borough reserves the right to limit the number of sets given to any bidder.

Bids must be prepared on the forms furnished with the specifications and must be enclosed in a sealed envelope. Bids must be plainly marked to indicate the name and address of the bidder and bear the word "**Bid**" upon the outside of the envelope. Bids may either be mailed or delivered in person. Mailed bids will be held and opened at the appropriate date and time. Bids received after the time for opening bids will be returned unopened. **All bids must be accompanied by electronic version in CD/DVD/ Flash Drive Form.**

The Borough reserves the right to reject any or all Bids for any and all causes as may be permissible in the Local Public Contracts Law.

Pursuant to N.J.S.A. 34:11-56.37 and 34:11-56.38 of the "Prevailing Wage Act," no public works contract may be awarded to any contractor and subcontractors or to any firm, corporation or partnership in which they have an interest while on the Debarred Contractors List until the expiration date given. The proposal is being solicited through a fair and open process in accordance with the N.J.S.A. 19:44A-20.4 et seq. Bidders are required to comply with the requirements of N.J.S.A. 10:5-31 et seq, and N.J.A.C. 17:27, which deal with Affirmative Action in relation to discrimination in connection with certain public contracts. All construction contracts equal to or greater than \$1,000,000 must comply with N.J.A.C. 17:27-7.4. All bids must comply with the local Public Contract Laws, N.J.S.A. 40A:11-1 et seq.
